A LAW OF THE MUSCOGEE (CREEK) NATION AMENDING MCNCA TITLE 15, CHAPTER 4, §§ 4-101 ENTITLED "PURPOSE" AND 4-102 ENTITLED "MUSCOGEE (CREEK) NATION CULTURAL & ARCHIVES DEPARTMENT REVOLVING FUND"

Be it enacted by the National Council of the Muscogee (Creek) Nation:

SECTION ONE. <u>AMENDMENT</u>. This amendment shall be codified in Title 15, Chapter 4 of the Code of Laws of the Muscogee (Creek) Nation; provided that for purposes of codification and amendment and its inclusion in pocket parts of the Code Laws of the Muscogee (Creek) Nation, the Codification Committee is hereby authorized: (1) to approve any changes related to the manner in which sections, articles, chapters and sub-chapters are designated consistent with the format in the Code of Laws published in 2010 by West Publishing Company; (2) to include footnoted references to the legislative history in said pocket parts to the Code of Laws and; (3) to note in said pocket parts any editorial correction of minor clerical or grammatical errors in the following amendment, without further National Council approval:

SECTION TWO. <u>AMENDMENT</u>. MCNCA Title 15, §4-101 is hereby amended to read as follows:

§4-101. Purpose

The purpose of this Act is to establish a Muscogee (Creek) Nation Cultural Center & Archives Department Revolving Fund for the performance of a site analysis and for the commission of architects, engineers and surveyors to render architectural and other drawings necessary for the building of an accredited cultural center and archives <u>and a</u> <u>welcome center/visitor center</u>.

SECTION THREE. <u>AMENDMENT</u>. MCNCA Title 15, §4-102 is hereby amended and a new §4-102.B is added, to read as follows:

§4-102. Muscogee (Creek) Nation Cultural Center & Archives Department Revolving Fund

A. There is hereby created the Muscogee (Creek) Nation Cultural Center & Archives Department Revolving Fund to pay for fees, costs and expenses associated with developing, designing, implementing and constructing a

nationally accredited museum, cultural center, and repository for Muscogee (Creek) Nation historical documents and artifacts <u>and a welcome center/visitor</u> <u>center</u>. This Muscogee (Creek) Nation Cultural Center & Archives Department Revolving Fund shall be held by the Muscogee (Creek) Nation Controller for the Muscogee (Creek) Nation Cultural Center & Archives Department. Expenditures shall only be made in accordance with the Muscogee (Creek) nation Accounting Policy and Procedures. Whenever this Revolving Fund contains less than twenty-five thousand and no/100 dollars (\$25,000.00), the Muscogee (Creek) Nation Cultural Center & Archives Department shall notify the Speaker of the National Council and the National Council may address a supplementat appropriation to replenish the Revolving Fund.

B. The Muscogee (Creek) Nation Cultural Center & Archives Department shall possess the ability to accept donations and raise funds for the Department through fundraising activities. Any funds received by the Muscogee (Creek) Nation Cultural Center & Archives Department through donation or fundraising activities shall be deposited in the Muscogee (Creek) Nation Cultural Center & Archives Department Revolving Fund and utilized as set forth in §4-102.A above.

SECTION FOUR. <u>EFFECTIVE DATE</u>. This Act shall become effective immediately upon proper approval and execution in accordance with the requirements of the Muscogee (Creek) Nation Constitution.


